Addendum to the 2021 President's Spring Letter

For clarity, the job responsibilities for the Vice President – Sites and Vice President – Tournaments were reviewed in relation to the Finance & Audit Committee. The Board reviewed the By-Laws prior to the 2017 changes and noted that the Tournament Chair was included on the Finance & Audit Committee. When the Tournament Chair's job was separated into Vice President – Sites and Vice President – Tournaments both positions were to be included on the Finance & Audit Committee.

It is therefore necessary to include the duties of the Vice-President – Tournaments in the By-Laws, which is shown in bold below.

By Law IV Officers and Directors – Section 3 – Duties of the Vice President – Tournaments. In accordance with her Procedure, the Vice President – Tournaments shall assume the responsibility for running all tournaments with the assistance of a committee chosen by her and the Vice President Sites. **She shall also be a member of the Finance & Audit Committee.** (change is in bold).

The Vice-President of Sites already has that statement: "She shall also be a member of the Finance & Audit Committee" noted in Duties of the Vice-President – Sites.

However, in the By-Laws section on Committees, the Vice President – Sites was inadvertently omitted from the list of members who serve on the Finance & Audit Committee. Therefore, the Vice President – Sites needs to be added to Finance & Audit Committee description, as noted below.

By Law V Committees – Section 4 – Finance & Audit Committee. The Finance & Audit Committee shall include the Treasurer as Chair, the **Vice President – Sites**, Vice President – Tournaments and the Tournament Awards and Trophies Chair. (**change is in bold**).
